**ADMISSION RULES OF THE COLLEGE**

**The Admission Process is strictly Merit-based and fully online** in adherence to Government Orders and Rules/Regulations of University of Kalyani.

1. Every applicant willing to take admission in Kalyani Mahavidyalaya **must read all notices and rules before applying**, particularly what is stated hereinafter

2. **Ignorance of Rules is no plea** (Rules = Govt. rules, University of Kalyani rules, College rules including the rules herein specified and listed)

3. All applications, if proper and found in order, shall be Merit Listed

**4. Merit List is not Admission Order**

**5. There shall be separate Merit List and separate Admission Order list on admission website**

6. Merit Listing (that is, name in Merit List) does not entitle an Applicant or confer any right to the Applicant to take Admission or pay Admission Fee unless Admission Order is issued by Online Admission Committee through College Website and by SMS. In other words, a merit listed Applicant shall pay Admission Fee only on receiving Admission Order through College Website and by SMS. **If anyone pays Admission Fee without receiving Admission Order, the said payment shall be considered unauthorized and may be forfeited**

7. Payment of Admission Fee on receiving Admission Order does not entitle an Applicant or confer any right to the Applicant to be considered "Admitted" unless all submissions in applications have been physically verified by Online Admission Committee and College Authority as deemed fit [date and time to be notified later]

8. When a Merit Listed Applicant pays Admission Fee on receiving Admission Order, it will be considered 'Provisional Admission', and the status of the Applicant shall be 'Provisionally Admitted' subject to initial online verification by Online Admission Committee

9. Provisional Admission does not entitle an Applicant or confer any right to the Applicant to be considered "Admitted" unless all submissions in applications have been physically verified by Online Admission Committee and College Authority to satisfaction

10. Any Provisional Admission may be declared Null and Void by the Online Admission Committee at any stage of the Admission Process if any information provided in Application is found incorrect or false at any stage of Admission Process whether before or after physical verification of documents.

11. After Provisional Admission, a provisionally admitted Applicant may cancel Provisional Admission only on payment of prescribed fee through the challan titled "**CANCELLATION OF ADMISSION – REFUND PRAYER**" in "**SBI Collect**". Prayer for cancellation/ TC of Provisional Admission and Prayer for Refund shall not be considered if submitted otherwise whether by e-mail, sms, whatsapp, hard copy letter etc.

12. Refund on cancellation shall be as per rules and subject to official cancellation as mentioned at point 11 above. **Applicants praying for refund on cancellation of provisional Admission shall not contact College Office unless notified. Notification shall be done in due time on College Website and as deemed fit by the College.**
